THROUGH OUR NOURISHING LIVES PORTFOLIO, THE ORGANIZATION WORKS ALONGSIDE COMMUNITIES TOWARD A FUTURE IN WHICH THEY CAN THRIVE, WHILE SUPPORTING SAFETY NET PROGRAMS THAT PROVIDE NOURISHMENT, SERVING AS A CONDUIT FOR SKILLS TRAINING OR SERVICES THAT SUPPORT THE JOURNEY OUT OF POVERTY. ONE IN THREE PEOPLE WORLDWIDE ARE ADVERSELY AFFECTED BY VITAMIN AND MINERAL DEFICIENCIES. THE ORGANIZATION'S MEALS ARE FORMULATED TO PROVIDE A COMPREHENSIVE ARRAY OF MINERALS AND MICRONUTRIENTS.
